## Law Libraries

### How can librarians help?

Librarians are available to help individuals with locating and using legal resources, both print and online. They can explain how to use sources of legal information, offer information about a law library near you, give you material for a school assignment, or refer you to a state agency that may provide information on a specific topic. It is unlawful for library staff to complete in-depth legal research for members of the public or provide legal advice. Law librarians are unable to interpret information appearing in legal publications such as Virginia's code or a court case.

The hypertext links will send the reader to a website where the information is located or send the reader to content within WorldCat. WorldCat.org is a free online catalog which allows the reader to browse the collections of thousands of libraries, including Virginia's public libraries. By clicking on one of the links to a WorldCat record, the reader will see a list of libraries that include that legal resource in their collection. From there, one can either directly access online content that is openly available or click on a link for the library nearest them.

## **Online Legal Information Resources - AALL**

AALL, the American Association of Law Libraries, has created an online legal information resource platform. It provides content for each of the United States, the District of Columbia, U.S. territories, U.S. Federal government, and Canada. The content includes session laws, codes, registers, and court opinions.
