# **Divorce**



## What happens in a Divorce?

A divorce case can handle the following issues:

- end the marriage
- reinstate a former name
- divide property and debt
- support of a spouse
- support of a child
- custody and visitation (parenting time)
- parentage issues if necessary

#### Which Court handles divorce?

Divorces are heard in <u>Circuit Court</u>. Custody, visitation, child support, parentage and spousal support may be resolved in the Juvenile and Domestic Relations District Court. After a divorce, requests to revise support, custody and visitation generally go to the Juvenile and Domestic Relations District Court.

#### What are the different kinds of divorce?

There are two kinds of divorces: No-Fault and At-Fault.

### What resources can help me understand the divorce process?
